### Explanation

The Council reviews the allowances and expenses scheme each year after considering the recommendations of an independent panel of people not connected in any way with the Council. The categories are as follows:  
 BASIC: All Members are entitled to a basic allowance.

SRA: Some Members are entitled to a Special Responsibility Allowance, usually because they chair a Committee

TRAVEL: Members are entitled to claim for car, motorbike or cycle mileage in accordance with an Inland Revenue

SUNDRIES: Whilst on Council business Members are entitled to reclaim certain necessary expenditure including postage

CONF: Members representing the Council at officially approved conferences may reclaim conference fees & accommodation

SUBSIS: Members participating in officially approved activities may reclaim actual expenditure on food and non-alcoholic drinks in accordance with specified maximum amounts conference fees & accommodation
